Lisa Navas and Mickey Dean lead a discussion surrounding the questions "How can this committee help the NCAA? What is the role this committee should have going forward?

Vickie Van Kleeck mentioned that it was up to the NFCA members to decide if the committee

has value. Vickie said that the NCAA rules committee's job was to implement rule changes based on recommendations from NCAA coaches. Her job as secretary is to disseminate information to coaches. If there are rule changes for 2020 then membership needs to be talking about them now.

Lisa asked for input as to whether the NFCA committee should or could be another step for rules discussions before a rule gets put into place by the NCAA. Can the NFCA committee help rules get debated before they are implemented and how and when can that be done?

Vickie Van Kleeck indicated that the NFCA Caucus meeting and Summits should be talking about rules and bringing feedback back to this committee.



NCAA Committee meetings are in June for rules discussions

Question: How can we have discussions about rules before they get moved forward? Lisa Navas expressed Rachel Lawson's concern that coaches do not respond to survey. This committee could help in getting info back from coaches.

Will bring the question of how this committee can help serve in rules proposals to the NFCA Board to see what direction to go.

John Smart - Suggestion is to use the NFCA committee to advise the NCAA rules committee on feelings from the coaches

Vickie – The NCAA rules committee adjusts rules based on proposals made by coaches There is a comment period for NCAA coaches for rule proposals, surveys Requests the NFCA to publish the NCAA calendar for rule changes

NFCA needs to continue to try to educate coaches about where to find rules, bat lists Goal is to try to educate coaches on how they can get the rules.

Coaches need to register with arbiter. NFCA could help remind coaches to register with arbiter and that they can find info about the new rules.

Mickey Dean

Expressed the frustration that there are rules in the book that are not being called. If people don't like the rules, then change the rules but call the rule until the rule is changed

Ouestion – What is the obstruction rule?

- You must have to have the ball before you can block the base. You can block the base once you have the ball.
- Throw at second base from catcher, you can straddle the base.
- Player is supposed to show half the base until the player has the ball.
